

ADVERTISEMENT FOR BIDS

Separate sealed bids for ORWEILER ROAD, RIC-TR152-0.20, BRIDGE REPLACEMENT, TROY/SPRINGFIELD TOWNSHIPS, RICHLAND COUNTY, OHIO will be received by the Richland County Board of Commissioners, County Administration Building, 50 Park Avenue East, Mansfield, Ohio 44902 until 10:30 AM local time APRIL 4, 2019, and then at said office publicly opened and read aloud.

Plans, specifications, estimated construction cost, and blank proposals must be obtained at RICHLAND BLUE PRINT.COM, INC., 1069 Park Ave. West, Mansfield, OH 44906 (Telephone Number 419-524-2781). The bidder must obtain the plans, specifications, etc. at their own expense and the cost is non-refundable. The plans and specifications may be obtained after MARCH 12, 2019.

- A. Each bidder requesting that a set of plans, specifications, etc. be mailed to the bidder shall pay the additional shipping and handling charges to Richland Blue Print.Com, Inc. Anyone requesting plans and specifications shall furnish a complete address (including street address) where these documents are to be mailed. Each bidder must also furnish their phone number and fax number.
- B. The list of those firms or persons obtaining plans, specifications, estimates and bid documents will be reported at Richland Blue Print.Com, Inc. ([www.richlandblueprint.com](http://www.richlandblueprint.com)).
- C. Bid proposals shall be submitted on forms furnished by Richland Blue Print.Com, Inc.

Each proposal must contain the full name of the party or parties making the same and all persons interested therein, and be accompanied, pursuant to Section 153.54 of the Ohio Revised Code, by a satisfactory BID GUARANTY: either a BID BOND or a BID AND PERFORMANCE PAYMENT BOND executed by the bidder and an acceptable surety, in an amount equal to one hundred percent (100%) of the total amount for each individual proposal; (pgs. 4 thru 4a), or, by a certified check, cashiers check, or a letter of credit pursuant to Chapter 1305 of the Ohio Revised Code in an amount equal to ten percent (10%) of the total amount for each individual proposal, payable to Richland County Board of Commissioners as a guarantee that if the proposal is accepted, a contract will be entered into.

Each bidder must have current ODOT prequalification for WORKTYPE 20, LEVEL 1 BRIDGE, and present their Certificate of Qualification at the time of the bid opening.

A valid Certificate of Compliance with Affirmative Action Programs, issued by the State EEO Coordinator dated prior to the date fixed for the opening of bids to be presented at the time of the bid opening.

Attention of bidders is particularly called to the prevailing wage rates to be paid under the contract.
