

ADVERTISEMENT FOR BIDS

Separate sealed bids for furnishing and installing on bedding prepared by others 18' x 7' CULVERT, WINGWALLS AND CUT-OFF WALL on WELLS ROAD, RIC-CR218-0.16, BLOOMINGGROVE TOWNSHIP, RICHLAND COUNTY, OHIO will be received by the Richland County Board of Commissioners, County Administration Building, 50 Park Avenue East, Mansfield, Ohio 44902 UNTIL 10:00 AM LOCAL TIME NOVEMBER 21, 2019 and then at said office publicly opened and read aloud.

Plans and bid documents shall be obtained at RICHLAND BLUE PRINT.COM, INC., 1069 Park Ave. West, Mansfield, OH 44906 (Telephone Number 419-524-2781). The bidder must obtain the plans, specifications, etc. at their own expense and the cost is non-refundable. The plans and specifications may be obtained after NOVEMBER 5, 2019.

- A. Each bidder requesting that a set of plans, specifications, etc. be mailed to the bidder shall pay the additional shipping and handling charges to Richland Blue Print.Com, Inc.
- B. The list of those firms or persons obtaining plans and bid documents will be reported at Richland Blue Print.Com, Inc.
- C. Bid proposals shall be submitted on forms furnished by Richland Blue Print.Com, Inc.

Each proposal must contain the full name of the party or parties making the same and all persons interested therein, and must be accompanied, pursuant to Section 153.54 of the Ohio Revised Code, by a satisfactory BID GUARANTY: either a BID BOND or a BID AND PERFORMANCE PAYMENT BOND executed by the bidder and an acceptable surety, in an amount equal to one hundred percent (100%) of the total amount for each individual proposal; OR by a certified check, cashiers check, or a letter of credit pursuant to Chapter 1305 of the Ohio Revised Code in an amount equal to ten percent (10%) of the total amount for each individual proposal, payable to Richland County Board of Commissioners as a guarantee that if the proposal is accepted, a contract will be entered into.

SPECIAL CONDITIONS – It is anticipated that the Richland County Road Superintendent will be ready for culvert, wingwalls and cut-off wall, to be placed on or about April 21, 2020. Work shall include furnishing and installing culvert, wingwalls and cut-off wall on bedding to be prepared by others. Backfilling and grading, work will be performed by others.

The Owner reserves the right to waive any informalities or to reject any or all bids.

The Contractor is not required to be ODOT prequalified for the installation of the concrete box culvert.

The manufacture of the the concrete box culvert must be by a firm that has a current ODOT prequalification for this type of manufacturing. The certification must be submitted with the shop drawings.
